Location(s): Any OLT property as required

Job Relationships: Maintenance staff repairs, maintains, builds infrastructure for OLT. Works closely with housekeeping and reception, as well as volunteers to keep the infrastructure in good shape and ready to provide amenities to visitors.

Position Overview: Under the supervision of the Facilities Manager, Facilities Staff is responsible for the maintenance of the Visitor Services facilities, including structures, utilities and grounds. The Facilities Manager also supports the construction of improvements on OLT properties.

Responsibilities include:

- Maintain all visitor services facilities including structures, utilities and grounds.
- Support the Facilities Manager and ED in planning and implementing improvements to facilities, including:
 - Research materials, designs and costs
 - Coordinate with volunteers, other departments, contractors, and any others in building, maintaining, and repairing systems and structures
 - Respond to weekend needs and emergencies as directed by the ED or Facilities Manager. Ideally, schedule includes at least one weekend day.

- Repair and maintain utilities including electrical, water supply, wastewater and fire protection.
 - Acquire complete familiarity with all utility systems including location of all underground installations
 - Follow and help implement emergency procedures for all utilities
 - Educate other staff on emergency procedures
- Follow maintenance schedules, facilities repair requirements, and operation instructions
- Implement and follow job safety policies and procedures for maintenance staff
- Facilities Staff are reviewed annually in accordance with the OLT employee handbook
- Instruct, work with, and supervise volunteers who are helping with maintenance tasks

- Ordering and/or purchasing and stocking parts and supplies
- Organization of tools and equipment
